## ASSIGNING SUPERVISOR


- Determination of the courses which the student enroll in and the registration Works are carried out by the relevant department until an supervisor is assigned.( Article 35/6)
- Board of the institution assigns an supervisor until the end of first semester at the latest upon the recommendation of the department (Article 35/2)
- When assigning the first supervisor for doctorate programs, the lecturer is required to assist at least one master's by thesis program as the first supervisor and help the student complete it successfully before. (Article 35/3).

## PH.D. PROFICIENCY APPLICATION -INFORMATION

Ph.D. Proficiency is held twice a year, that is one in Autumn, one in Spring term

- "Profieciency Stage" should be chosen in the course registration system.
- Students whose masters degree is approved should take this exam at the end of 5th semester
  at the latest.
- Students who are usuccessful at the exams twice are discharged from the institute.

## ESTABLISHING PROFICIENCY EXAM COMMİTTEE

- A exam committee of 5-peolpe-Ph.D. ProficiencyCcommittee, recommended and approved by the department for **each school year**, holds the exam.
- exam committee constitutes 5 proffessors, at least two of which are from outside the
  institute, including the supervisor. (Article 36/3).



#### PROFICIENCY EXAM

The exam committee decides whether the student is successful or not with absolute majority

board of the directors of the department of the gradute school. (Article 36/4)

## ESTABLISHING THESIS MONITORING COMMITTEE

- A Ph.D. thesis monitoring committee is established upon taking the opinion of the supervisor, the suggestion of the concerned presidential and the decision of the Board of the Directors of the Institute within **one month** at the latest. (Article 37/1).
- Thesis monitoring committee comprised of three faculty members including the supervisor. One of the two remaining members is selected within the concerned department/science chair, the other one is selected primarily from another higher institution or from another department/science chair within the university. (Article 37/2).

#### THESIS PROPOSAL REPORT SUBMISSION

Student being successful in the profieciency exam, submits the thesis proposal report consisting the aim, methodology and plan of the study to the committee membersat least 15 days before the oral defense date (Article 38/1).


#### THESIS PROPOSAL DEFENSE

- The student who successfully passes the proficiency exam defends their thesis proposal that covers the scope, method and the plan of the study orally in front of the thesis monitoring committee within the six months at the latest (Article 38/1).
- The thesis monitoring committee decides whether to accept or refuse the thesis proposal with absolute majority. One month is given for the correction. The concerned presidential delivers the decision of the thesis monitoring committee with an official report including reasons within three days following the defense. (Article 38/3).

#### TMC MEETINGS


- The thesis monitoring committee gathers twice a year; one in January- June and one in July-December for a student whose thesis proposal is accepted. The student presents a written report at least one month before the meeting. The summary of the studies conducted until that moment and the studies that will be done in the next semester is stated in this report. The student's thesis study is assessed as successful or unsuccessful. The decision is delivered to the relevant institute with an official report within three days following the defense. In case of failure, the reasons are added to the official report (Article 38/6).
- Whether the committe gathers or not, in case of being "unsuccessful" twice or three times, the student is discgharged (Article 38/7).


#### SUPERVISOR THESIS CONTROL AND RECOMMENDATION OF EXAM COMMITTEE MEMBERS

The student who fulfils the publication condition submits their Ph.D. thesis to the institute by taking the approval of their supervisor (the written opinion stating the convenience of the thesis to the spelling rules).(Article 39/4, article 39/2). Ph.D. thesis exam committee is determined by the Board of Directors of the Institute amongst five academic members who are suggested by the supervisor r with the thesis monitoring committee and five academic members suggested by the concerned department/science (Article 39/5).

#### ASSIGNING EXAM COMMITTEE MEMBERS

The exam committee is determined with the decision of IAC among total of ten members, five of whom are academicians to be suggested including the supervisor along with TMC committee and five other of whom are academicians to be recommended by department chairmanship. The exam committee consists of at least five people, thesis monitoring committee and at least two other from another higher education institution. If there is a second supervisor, it consists of seven original and two substitute members (Article 39/5).
